1. Please print your name and member or dealer number in the space provided.
2. Clearly write return shipping address, phone number and email address.
3. Place each note in a new mylar sleeve with the submission number and line number listed. Do not send notes with the holder closed with tape, staples, screw-type plastic holders or in any other manner.
4. List each note description on the lines on the reverse side of this Submission Form. For multiple notes of the same date, denomination, catalog number, type and variety, you may list the total quantity and enter them on one line. Indicate an insured value for each note. In the case of multiple notes on one line, list the insured value as a total of all notes on that line. **Please note that all non-regular issue notes, including but not limited to Specimens, Proofs, Color Trials, Essays, Error notes, or any notes or varieties not listed in the Friedberg, Charlton, Haxby, or Standard Catalog of World Paper Money references, are subject to additional fees. Please note that a \$5 research fee per note will be added to any submission that does not include the correct catalog number for each note.**
5. Select the type of submission and service level desired. **Only one type of submission, at one service level, is permitted per submission form.**
6. Calculate the grading fees and shipping cost (refer to chart below). You are required to provide return shipping for each order. Please note this shipping and insurance cost covers return shipments from Legacy Currency Grading only. Please remit the proper fees. **Please do not send postage stamps** for the return of your package.
7. If any fees are incorrectly calculated, Legacy Currency Grading reserves the right to modify the submission form with the correct fees, and to charge additional fees as necessary. If a credit card is provided by the customer as their form of payment, the card will be charged for the corrected amount of the submission and the customer will receive email notification that the charge will be different than originally calculated. If the customer paid by check or cash, he or she will be contacted to request additional payment. Any underpayment or delay in receipt of payment will delay processing of any submission.
8. 1. Legacy Currency Grading will endeavor to grade items within the time frame, if any, offered as part of a Legacy Currency Grading service tier. However, Legacy Currency Grading will have no liability whatsoever to the customer for incidental or consequential damages due to Legacy Currency Grading failure to grade any item within any time frame. In the event that the return of a submission is delayed for any reason, the terms of the Legacy Currency Grading Service Guarantee shall apply. 2. Legacy Currency Grading will not grade items which, in the opinion of Legacy Currency Grading, bear evidence of significant alteration, unstable paper quality, or similar impairments, or are of questionable authenticity. In the event Legacy Currency Grading rejects any item for grading in accordance with Legacy Currency Grading current grading standards and procedures, Legacy Currency Grading shall not refund the fee paid by customer.
3. Grading involves individual judgments that are subjective and require the exercise of professional opinion, which can change from time to time. Therefore, Legacy Currency Grading makes no warranty or representation and shall have no liability whatsoever to the customer for the grade assigned by Legacy Currency Grading to any item, except pursuant to Legacy Currency Grading guarantee resubmission, re-verification or regrade service as in effect from time to time. 6.
